

Live Online with Mystery & Beckster Mentorship Agreement Form

This agreement ("Agreement") is made and entered into on the date of acceptance by both parties to this Agreement. This Agreement is between the mentor, ("Mystery") and the mentee ("Mentee").

1. Partnership. Both Mystery and Mentee agree to voluntarily enter into this partnership for a rewarding experience that leads to Mentee acquiring a considerably improved Pickup Artist skillset.
2. Duration and Payment. The mentoring relationship will last from May 6th to May 20th, 2023. The payment for attending this online mentorship program is \$2,497 USD upfront, which shall be sent in a timely manner before our lecture meeting starts.
3. Cancellation. Cancelling the mentorship is possible only under compelling circumstances (serious illness). The \$2,497 USD payment is non-refundable. In case a single live online lecture cannot be attended, both Mystery and Mentee shall agree that access to a recording of the missed event will suffice.
4. Meeting Schedule. We will meet online at 11am PST, starting on May 6th, 2023. Meeting times, once agreed, should not be cancelled unless this is unavoidable. WhatsApp communications with Mystery will take place in between Saturdays.
5. Meeting Duration. Each Zoom call will last for 2.5 hours, approx.
6. Communication. Between meetings, we will keep in touch through the WhatsApp Live Online with Mystery support group. Mystery will be responding to questions regularly.
7. Goals. The aim of the partnership is to focus on improving the following skills: (a) cold approach pickup; (b) dynamic interactions in groups; and (c) social circle acquirement.
8. Confidentiality. Any of Mystery's material may not be spread to audiences for commercial purposes or taught without permission. We agree to keep the content of these meetings confidential.
9. Role of Mentor. Mystery agrees to provide 3 Saturdays of lectures starting May 6th, 2020. Additionally, Mystery shall keep track of and communicate with Mentee through the support group regularly.
10. Role of Mentee. Mentee agrees to ensure that the mentorship payment is sent by the night before the Zoom call. Mentee commits to improving their pickup artist skillset and working towards it while hopefully enjoying a once in a lifetime experience. Mentee shall voice concerns or complaints they might have directly and immediately to Mystery so we may solve them together.
11. Feedback. The mentor agrees to be honest and provide constructive feedback to the mentee. The mentee agrees to be open to the feedback.
